Our focus has turned to winning new partnerships, and our teams have been strengthened to better implement our ambitions.



# ACCELERATION PROGRAMS





PME Performantes WASH-Climat 2.0 aims to scale up the activities of 10 SMEs during 18 months by strengthening their organizational skills. It is developed and deployed by ForthInvestment, in collaboration with the Aqua for All Foundation.

Over the course of 2023, the 10 SMEs were selected and a tailor-made support package was defined and implemented.

These companies are building boreholes, market irrigation systems, hydroponics systems, drinking water kiosks....

They operate in the Centre and Hauts Bassins regions of Burkina Faso, and in Benin.

The program is structured in three (03) main stages:



Companies' selection;



Technical, organizational, strategic, commercial, human and financial support.



Preparation for accessing financing

Through this program, SMEs have improved their accounting management, improved their products/ services, benefited from grants to increase their visibility in terms of communication, recruited and trained their teams.

# BIODIGESTER SECTOR SUPPORT PROGRAM

Impact rural communities by promoting biodigester sector enterprises

Under the mandate of the Nation Program of Biodigester of Burkina-Faso (PNB-BF) and the World Bank, the expertise of ForthInvestment was requested to support sixteen (16) biodigester construction companies. These companies are based in the regions of Tenkodogo, Koupéla, Léo, Dédougou, Banfora, Gaoua and Ouahigouya.

This support was structured around the following activities:



Funding research



Structuring the biodigester industry

Our support has strengthened the companies' business model, empowered them in their marketing approach and revitalized the umbrella organization (AProBER).

#### PME PERFORMANTES SCALE

202K€

Allow access to financing for WASH SMEs to contribute to changes in the sector

Launched on March 1, 2023, PME Performantes SCALE aims to facilitate the financial inclusion of SMEs in the water and sanitation sectors, in particular those marketing water filters, food-grade chlorine, mobile ecological toilets, and mechanical and manual emptying services.

Initiated by ForthInvestment in collaboration with the Aqua for All and Vitol foundations, this program aims to provide SMEs in the WASH sector with initial experience and a track record in credit management. Through this 31-month program, eleven (11) companies received financing for a total of over €202,457. The main activities involved in implementing the program are as follows:

- Financing;
- Post-financing follow-up: to support entrepreneurs in implementing the projects they have financed, while assisting them in repaying their loans.

SME financing has enabled them to set up public toilets, purchase and store raw materials, organize awareness-raising campaigns and sessions in periurban areas.

# Boosting SME growth to create inclusive jobs



Job and Business Booster (JBB) is a program implemented in consortium with the Dutch foundation Woord en Daad and co-financed by the Challenge Fund for Youth Employment.

Its main objective is to support 360 young entrepreneurs, 50% of whom are women, over a 3-year period, with the aim of creating and consolidating 1080 decent jobs.

JBB targets companies in the agribusiness, food processing, livestock, solar panel installation and marketing, biochar manufacturing and renewable energy sectors.

The areas of intervention are the Centre, Hauts-Bassins, Boucle du Mouhoun, Cascades, Centre-West, Centre East, Centre-North and South-West regions.

The JBB program includes four (04) main activities:

Pre-financing support consisting an organizational, financial, strategic and human resources diagnosis, with a view to providing investment readiness assistance.

Support for access to financing through the preparation of financing files and approaching the financial institutions.

Post-financing support for the implementation of the financed project and the effective repayment of the debt.





Job intermediation: facilitating contact between job seekers and employers.

JBB program activities have helped to create decent jobs for young people, improve promoters' business management skills, and encourage the implementation of effective financial management practices.

#### SOME COMPANIES SUPPORTED























During the first quarter of 2023, ForthInvestment carried out due diligence on behalf of the Belgian investment fund Kampani on a cooperative in Burkina Faso. Our analysis enabled them to assess the potential for implementing the cooperative's financing project and its ability to repay the loan requested from the investment fund.





During 2023, ForthInvestment was selected by Niras, a UK firm, as part of the Energy Enterprise Coach (EEC) program to train and coach impact businesses. ForthInvestment has developed and delivered training courses on the fundamentals of business management for twelve (12) companies in the renewable energy sector.





#### 1. World Water Week

Entrepreneurs, investors and stakeholders from the WASH sector gathered from August 20 to 24, 2023, in Stockholm, Sweden for World Water Week. ForthInvestment did not miss this international event, and shared its experience as a WASH SME accelerator as a speaker in a session entitled "The voice of SMEs: better enabling seeds of change". This session enabled us to share our experience in supporting WASH SMEs, their main difficulties, particularly in West Africa, and the essential levers for their development.

We have learned from this event that combining expertise and financing is a crucial factor in meeting the challenges of SMEs and creating a growing impact.

For Impact Week 2023, over 1,000 people and organizations from the impact ecosystem were expected in Turin (Italy), including ForthInvestment. #### AGENCE BAALI INNOVATION

specializes in the construction of biodigesters and the marketing of biodigester by-products such as compost and biogas. To this end, it is helping to reduce deforestation in the Cascades region.

#### **ENTREPRISE SOLEIL LEVANT**

Located in the Nord region, it contributes to the reduction of greenhouse gases through the construction of biodigesters, the marketing of compost and biogas equipment.

#### ENTREPRISE SIDLABOUMBOU

Through the construction of biodigesters, Sidlaboumbou plays an active role in the recovery of human and animal waste in the Centre-Est region.







#### COOPERATIVE NUNA BIOGAZ

This cooperative is involved in biodigester construction and the sale of biogas equipment in the Centre-Ouest region. It promotes the use of organic fertilizer produced by biodigesters, which is more beneficial than chemical fertilizer for soil restoration and enrichment.

working in the biodigester sector, EECS offers a wide range of services, including biodigester construction, the sale of biogas equipment and the marketing of biopesticides and livestock feed. It contributes to improving living conditions for the populations of the Boucle du Mouhoun region.

#### AGENCE D'EXECUTION DE PROJETS ET ETUDES (AGEPE)

An expert in the construction of biodigesters and the sale of biogas equipment, AGEPE allows women to save nearly three (03) hours a week in the search for wood. This enables women in the South-West region to develop income-generating activities.


Through biodigester construction and product marketing, CRCB enables households in the Centre-Est and Centre-Sud regions to produce their own organic fertilizer.

Specialized in building and public works, TGBB is also active in the construction of biodigesters. Through its expertise in the field, it provides solutions that improve soil fertilization and enhance the living conditions of farmers in the Centre-Est region.
